DONATIONS FOR MEALS (DHANA) FOR CHILDREN AT 'SINGITHI SEVANA' CHILDREN'S HOME

The above home which is managed by our society is registered with the Department of Probation and Child Care to provide resident-care for 2-12 year old children. Admission and release of children is through the Department. At any given time there are around 35 children and about 8 on the staff.

The society needs to generate funds to meet children's needs, staff salaries, school transport as well as maintenance of the buildings which have been constructed with society funds. The government's yearly grant per child is currently Rs.300/month and is totally inadequate to meet these expenses. Further, such funds are released only after a lot of paper-work at years- end and the date of receipt of the annual grant is also very variable.

One of the key items of expenditure is in providing meals to the children and with the rising cost of food items feeding the children is a major concern for the society.

Hence we appeal to you to assist us by sponsoring a meal, either in cash or kind, for a day once a year. The cost of a meal is shown below.

Breakfast	-Rs.1,500.00
Lunch	-Rs.2,500.00
Tea	-Rs. 750.00
Dinner	-Rs.2,500.00

Alternately, cooked meals can be brought or the food stuffs handed over for the meal that you sponsor. In such event the above costs do not apply.
